2.0 New Business

2.1 International Students

Mubarak wanted to address monthly newsletter to international students, regarding their asks of him. Feels we fell short in November. Karley has a lot to do and doesn't want to add more to it. Sent on December 1, to the group of international students. Students are not allowed to send mass emails to students at the college. Amanda explained that unless you've collected the emails, you cannot use the college data base to contact. These emails should go through Karley.

Mubarak asks what the solution to getting these newsletters out to international students. Amanda explained that we cannot force IT to get us mailing lists faster.

International Trade Fair – show casing crafts at a discounted price – this could take place in Crossroads or the SA Event Space. Mubarak is thinking this could





take place between 12-1PM during the students' common block. Mubarak is looking for advice as to whether this should be run as a club or council event. He would like this event to take place before the end of the year, however we have lots of events lined up so it's looking like it will have to take place sometime in January. Justice Constant mentioned that Indigenous crafts could be sold as well as part of the International Trade Fair. Tabled for now.

Another Change: We are making the Remote Campus individual a nonexecutive individual.

We've been discussing hiring a new staff member to take over the Rural Rotating Committee to support all the rural campuses. They would support the committee, representatives and council members as the regular SA staff do. Emma Babiak advised that there could just be more reps instead of a staff hire, and she advised that she would have liked to voice her opinion before the decision for a remote campus individual to be a non-executive individual.

Amanda suggested we leave the rural campus individual as an executive. Emma advised there are lots of rural campuses and not enough representatives to support the campuses.
